Customs clearance takes approximately 10 business days from the date of shipment arrival. The items and weights identified on the OBL must match the actual items in the shipment or a fine of 250 USD will be levied and clearance will be delayed. All shipments are subject to physical. Costa Rican customs authority is organized as the Servicio Nacional de Aduanas. The legal framework of customs regulations falls under the General Law of Customs and its Regulatory statement and the Central American Uniform. Uncleared goods will be stored at the Customs Airport Warehouse up to 90 days with possible extension up to one year upon application. Inflammable goods may remain stored for 10 day only.
